

Aetna donates \$50,000 to Iowa Association of Community Providers



Funding will support enhanced technology services and professional development of Medicaidfocused providers, organizations and direct support professionals

URBANDALE, IA, Aug. 8, 2022 – The <u>Iowa Association of Community Providers</u> (IACP), an organization committed to improving the quality of life of 160,000 Iowans who have significant challenges with mental health and disabilities, announced a \$50,000 donation from Aetna Health of Iowa Inc., dba Aetna Better Health of Iowa, a CVS Health® company (NYSE: CVS).

The donation will help support enhanced technology services and professional development of Medicaid-focused providers, IACP member organizations and direct support professionals (DSPs) who empower people experiencing mental health and disability challenges to overcome barriers that would otherwise prevent them from being self-sufficient.

"Iowa's mental health and disability services is in the midst of a workforce shortage," said Shelly Chandler, CEO of the Iowa Association of Community Providers. "Our <u>recent survey</u> of IACP members showed that 94% have DSP vacancies and a DSP annual turnover rate of 39%. We're grateful for Aetna's generous donation, which will enable us to develop creative approaches to maintaining services that keep Medicaid members living at home, if they choose, and out of residential facilities."

IACP is using a portion of Aetna's donation to fund Innovation Grant pilots to member organizations that seek to address critical barriers within the industry through new and innovative ideas. IACP <u>recently announced</u> the three Innovation Grant recipients.

In addition to the pilots, IACP will use some of Aetna's funding to support the curriculum for IACP's Fall 2022 Leadership Webinar Series training and education sessions that help support the success of health care providers in addressing historic workforce shortages.

"Given the shortage of disability service providers, access to enhanced technology and a skilled staff are vital to keeping people experiencing mental health and disability challenges healthy, safe and self-sufficient," said Ted Koutsoubas, Aetna Medicaid Chief Strategy Officer. "We look forward to seeing the results of IACP's innovative programs, which align to Governor Reynolds' vision for Iowa."
